

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.quirenano.com and Qure Nutraceuticals and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Qure Nutraceuticals include www.quirenano.com and Qure Nano CBD. The Qure Nano CBD website is a Ecommerce site. By using the Qure Nano CBD website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Qure Nano CBD may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Qure Nano CBD's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Automatically Collected Information

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
